2. Analytical justification of the EP

2.1 Information about the educational program

The content of the educational program is established by the State Mandatory Standard of Higher and Postgraduate Education No. 604 dated October 31, 2018 (Approved by the Decree of the Government of the Republic of Kazakhstan, State license No. 13013970 issued on 28.08.2013 and an appendix to state license No. 009.

License for conducting an educational program series no.KZ041AA00032042, dated 12.03.2009Educational programs are implemented through curricula (standard, individual and work) and programs (standard isillabuses).

The educational program "8D01101 Pedagogy and Psychology" is aimed at training a highly educated specialist in the field of pedagogy and psychology, competitive in the global educational space in the context of globalization and modernization of science and society. The educational program 8D01101 Pedagogy and Psychology is implemented by the Department of Pedagogy and Psychology of the Faculty of Humanities of the Educational Institution "ALIKHAN BOKEIKHAN UNIVERSITY". The program assumes the preparation of a highly educated specialist in the field of pedagogy and psychology, competitive in the global educational space in the context of globalization and modernization of science and society, to possess modern technologies for designing and organizing scientific research in professional activities.

The educational program has been developed in accordance with the National Qualifications Framework and Professional Standards, coordinated with the Dublin Descriptors and the European Qualifications Framework. Personnel training is conducted for the field of education.

Training of personnel on the educational program "8D01101 Pedagogy and psychology" is conducted by smagistratura. Doctoral students are issued to work as specialists adapted to the changing requirements of the labor market and able to carry out psychological and pedagogical support of subjects of the educational process of educational institutions of various types, subjects of social and specialized organizations.

The objects of professional activity are:higher educational institutions; research institutes, centers; state institutions (departments of the Department of Education); institute of advanced training.

The educational program meets the needs of the Republic of Kazakhstan for highly qualified specialists in the field of psychological and pedagogical activity in scientific research and teaching of professional disciplines.

The development of the educational program is provided with all the following necessary resources: financial, informational, personnel, material and technical base.

2.2 Information about students

The organization of the educational process is aimed at ensuring the quality of the services provided, creating the same comfortable, favorable conditions for all students. Student-centered education (Student-CentredApproachinEducation) is "the fundamental principle of the Bologna reforms in higher education, suggesting a shift in emphasis in the educational process from teaching (as the main role of scientific and pedagogical workers in the translation of "knowledge") to teaching (as an active educational activity of the student)." The educational program at the levels of education creates the most favorable conditions for students to master all disciplines of the OP and receive a degree (upon completion of training) in accordance with the requirements of the State Educational Standard of the Republic of Kazakhstan. Each student is provided with a reference guide (updated annually for the admission of the first year) in Kazakh and Russian languages for the formation of an individual educational trajectory, presentation of elective courses, organization and conduct of scientific research, internships.

OP "8D01101 Pedagogy and Psychology" implements student-centered learning through the fundamental principle of the Bologna reforms in postgraduate education, which shifts the emphasis in the educational process from teaching ("translation" of teaching staff knowledge) to teaching (active educational activity of the student), and organizes the teaching of students as a subject, in psychological and pedagogical activities in integration with innovative technologies for the formation of professional competencies of students and researchers.

Independent work of students is considered as a form of organization of training, which is able to provide independent search for the necessary information, creative perception and understanding of educational material during classroom classes, various forms of cognitive activity in the classroom and in extracurricular time, the development of analytical abilities, control skills and planning of school time, the development of skills and skills of rational organization of educational work.

Potential applicants of OP8D01101 "Pedagogy and Psychology" make up the main part of the masters of the highest educational institutions of the East Kazakhstan region and other cities of the Republic of Kazakhstan.

Admission of students to the OP 8D01101 "Pedagogy and Psychology" is made on the basis of the rules for admission of doctoral students to the educational institution "ALIKHANBOKEIKHANUNIVERSITY", in accordance with the Standard Rules of the Republic of Kazakhstan for admission to educational organizations implementing professional training programs of postgraduate education.

The formation of a contingent for this educational program is carried out through budget financing – the placement of a state educational order for the training of specialists, the payment of tuition at the expense of citizens' own funds.

The competitive selection of masters takes into account the number of points scored when passing CT corresponding to the standards of the Ministry of

Education and Science of the Republic of Kazakhstan for admission to doctoral studies.

The employment of graduates of the university is headed by the Career Center, which is a structural unit of the educational institution "ALIKHAN BOKEIKHAN UNIVERSITY".

The main goal of the Center is to promote the employment of graduates, as well as to create conditions for the effective career building of university students.

2.3 Internal and external conditions for the development of EP

The educational program is aimed at ensuring the modern quality of education based on the preservation of its fundamental nature, the unification of educational standards and programs taking into account global trends, the development of intellectual, innovative potential of society, the combination of vocational education with the development of humanitarian culture, the formation of a spiritually rich, intellectually equipped, socially responsible personality.

The prospect of developing professional competencies through doctoral studies; Internet access, including the electronic library of the university and the resources of the scientific library of the university (the library fund is equipped with printed and electronic publications, educational and scientific literature on the disciplines of the specialty). Teachers implementing the educational program have the potential for development, that is, the desire for improvement and self-development through the integration of educational, scientific and innovative activities in their work.

The teaching staff of the department systematically improves their qualifications through courses, classes of the scientific and methodological seminar of the department. The result of this is the application of various methods and forms in the learning process. The following teaching methods are widely used in the content of lectures and seminars:

- Lectures in the technology of development of critical thinking, contextual, problem-based, modular, reflexive learning;
- Seminars: compiling a bibliography on the topic; different types of reading, highlighting the main idea, taking notes; discussion of scientific papers read;
- consulting on the formulation of the object and subject of research, topics, hypotheses, understanding the goals and objectives of the work, according to the methodology of the study; planning and conducting an experiment, collecting material;

- analysis of the work done, discussion of long-term plans.

According to the schedule of the educational and methodological map of knowledge control, the teaching staff of the department regularly attend classes in order to exchange experience. The effectiveness of the educational program is ensured through the use of teaching staff in the educational process of innovative learning technologies.

Mutual visits of training sessions help the teacher to carry out a component-by-component assessment of his pedagogical activity and the pedagogical activity of the visited teacher, in particular: the volitional component (the teacher's ability to make decisions and fully implement these decisions; the cognitive component (the teacher's ability to search and find the necessary information, use this information for development and self-improvement); the emotional component (the formation of the teacher's attitude to his professional activity and its result); the motivational component (the teacher's awareness of the key idea and mission of his scientific and educational activities).

The professional skills of the teachers of the department are being improved during mutual visits of classes, conducting open classes, conducting educational and methodological and scientific-theoretical seminars, professional development, and work continues on the topic of the scientific direction of the department: "Actual problems of modern psychological and pedagogical science: trends, solutions".

In order to implement the program of scientific research activities, a joint work is being carried out by the sNAO "Shakarim Semey University", "Semey Multidisciplinary College", the Center for Psychological and Pedagogical Research, the office for research activities of undergraduates and doctoral students at the university.

The teaching staff of the department actively uses innovative educational technologies and modern teaching methods in the classroom. In the classroom, senior lecturer, Ph.D. Mukusheva B.S. used such types of work as: problem lecture, business games; PhD Doctor A.K. Mamanova applies work in subgroups, compiling a dictionary of basic concepts and terms on the subject, the methodology of problem presentation; senior lecturer, Ph.D. Sultanova N.K. uses individual and group forms of work aimed at mastering knowledge and forming social interaction and partnership.
