Supplements to the documents on education of the university's own sample shall be filled in as follows:

- 1) surname, first name, patronymic (if any) should be given in full;
- 2) name of disciplines, number of ECTS academic credits. Grade (in alphabetical equivalent, in points and traditional (in words));
- 3) In the line "Final attestation", the name, number of ECTS academic credits and grade (in alphabetical equivalent, in points and traditional (in words)) shall be indicated. If a comprehensive examination is taken, the names of the disciplines included in the comprehensive examination are indicated and a single grade is awarded;
- 4) In the line "Previous educational document", the name of the educational document on the basis of which the person was enrolled in the university, the document number and the year of issue shall be indicated;
- 5) In the lines "Enrolled in" and "Graduated from", the year of enrollment and year of graduation should be given in four digits, respectively, as well as the full name of the educational institution where the person was enrolled and the name of the university that the person has graduated from;
- 6) in the line "The total number of mastered academic credits - ECTS" - the number of credits is indicated in digits;
- 7) in the line "Grade Point Average (GPA)" - the average score for the whole period of study is indicated in digits;
- 8) in the line "Professional practice" the name and the number of academic credits shall be indicated;
- 9) in the line "Number of credits of theoretical studying" and "Number of ECTS credits of theoretical studying" - the number of credits of theoretical studying shall be indicated in digits;
- 10) in the line "Decision of the Attestation Commission", the number of the minutes and the date shall be indicated in digits;
- 11) in the line "Degree/qualification awarded", the degree/qualification is indicated;
- 12) in the line "In the specialty and (or) educational program", the code and name of the specialty and (or) educational program shall be indicated;
- 13) in the line "Level of correspondence to the national qualification framework", the level is indicated in digits: for Bachelor's degree - 6, for Master's degree - 7, for Doctoral degree - 8. Supplements to the educational documents of the university's own sample shall be signed by the head of the university in the designated place for seal.

Note: Logos (or) names of accreditation agencies for specialized accreditation of educational programs are placed in the supplement to the documents on education of the university's own sample
