Summary of the sections of the MEP

1. Explanatory note

The modular educational program (MEP) was compiled in accordance with the State Educational Standard approved by Order No. 604 of the Ministry of Education and Science of the Republic of Kazakhstan dated October 31, 2018, also on the basis of the provision «On the formation of the students' learning trajectory» P.01.04.2012. Structure of the modular educational program from 17.01.2014

The MEP is developed as a set and sequence of training modules for the entire period of study and is aimed at mastering the competencies necessary for awarding the academic Bachelor of Public Safety degree, according to the educational program 6B12330 -«Law Enforcement», the OOD block includes disciplines for all MEP specialties of education (total 56 credits), during the study of which the graduate must master the key competencies of general education and socio-ethical.

He DB block includes the disciplines of the university component (VC), which is 37 credits; and elective components (CV), which is 75 credits. Modules of these disciplines allow forming a complex of key (systematizing and socio-ethical) and special competencies acquired by the graduate.

The PD block includes the disciplines of the university component (VC), which is 23 credits; and the elective component (CV), which is 37 credits. Modules of these disciplines allow you to form a complex of key and special (production, management and research) competencies acquired by a graduate. In total, a student at the end of the MEP must master 240 credits.

The purpose of the training is to deepen professionally significant knowledge in the field of the future profession, expand the scope of skills and abilities in the specialty, including solving practical problems in substantive and procedural law and conducting an examination of regulatory documents; to form knowledge, skills and skills in the pre-trial investigation of a criminal case, operational and official activities of law enforcement agencies, judicial review of criminal, civil and administrative cases.

The educational mission of the educational program 6B12330 «Law Enforcement» is to train competitive personnel of higher and postgraduate education in a wide range of areas, focused on accelerated industrial and innovative development of the region. The vision is to meet the changing needs and expectations of society and all stakeholders.

The field of activity of a graduate of the educational program 6B12330 «Law enforcement»: a specialist or a court secretary; a lawyer of akimat, maslikhat and enterprises with various forms of ownership; a lawyer-consultant in the legal departments of organizations, institutions, including in the EurAsEC countries; a lawyer in a law office or bar association; a notary in a notary office.

<u>1. The graduate's competence model</u>

In modern conditions, the key resource of the country's economic growth is the intellectual and educational potential. In this regard, the system of training highly qualified personnel is becoming important in ensuring high competitiveness.

The competitiveness of a specialist is determined by his professional competence, broad social outlook, flexibility of behavior and a high level of individual activity. The competence-based approach in higher professional education opens up wide opportunities for better training of specialists for real life. The competence of the graduate is formed taking into account the needs and satisfaction of the labor market. In modern conditions of the labor market, there is an increasing need for competent legal specialists, as well as civil servants with a multilingual direction. The demand for practical skills and qualifications focused on entrepreneurial activity is increasing.

Special competencies are divided into production and management and research competence.

Production and management competencies:

Be able to: analyze and solve legal gaps of a theoretical and practical nature in the field of international operational investigative activities of law enforcement agencies.

Master: the basic concepts and terms of the ORDO and international cooperation in criminal matters.

To know: the procedure for the implementation of criminal prosecution by the bodies of inquiry and the procedure for the supervision of the Prosecutor's office over the execution of laws.

Be able to: identify, prevent, suppress and disclose criminal offenses, as well as identify and identify persons preparing, committing or committing them, and also be able to analyze the functions and tasks of the prosecutor's office for the enforcement of laws.

Possess: basic concepts and terms of the CPC of the Republic of Kazakhstan and the Law of the Republic of Kazakhstan «On the Prosecutor's Office».

To know: the basis, procedure and implementation of judicial evidence in administrative, civil and criminal cases, the grounds for conducting a forensic examination and apply the knowledge gained during the court session.

Research competencies:

The result of mastering the program the professional module is the acquisition by students of a type of professional activity in the field of law enforcement: knowledge of the laws of the development of society and its socio-political, legal, economic, environmental foundations, as well as cultural and historical values, the basics of computer science, language communication and understanding of the principles of a healthy lifestyle; possession of information about political life in the Republic of Kazakhstan; to form professional qualities covering deep scientific-theoretical and methodological knowledge, practical skills, skills in historical-theoretical and branch sciences in the field of law enforcement, the ability to analyze and solve problems of a theoretical and practical nature

in professional activity; to form professional qualities including theoretical and empirical knowledge, as well as skills and skills for practical actions; professional use of special equipment, strict compliance with the secrecy regime, the ability to analyze and solve legal gaps of a theoretical and practical nature in the field of operational and official activities of law enforcement agencies.

Requirements for special bachelor's competencies in the educational program 6B12330 «Law Enforcement»: The graduate must:

To know: the normative base of the criminal, criminal procedure, criminal enforcement proceedings of the Republic of Kazakhstan, and in particular such constitutional laws and laws as: the Law «On the Prosecutor's Office of the Republic of Kazakhstan», the Law «On Internal Affairs Bodies», the law «On National Security Bodies», the law «On the judicial system and the status of judges»; the basic rules for drafting criminal procedural documents; the main methods and methods of investigation of certain types of criminal offenses;

Be able to: draw up criminal procedural documents of pre-trial and judicial proceedings; use normative legal acts in professional activities; understand the introduced legislative innovations; logically express and justify their point of view competently; carry out competent document management; analyze and solve legal problems in the field of criminal law relations; provide legal assistance to individuals and legal entities, manage their emotional state, as well as have good operational memory, developed verbal-logical and analytical thinking, tolerance, responsibility and organization;

Have the skills to: work with normative legal acts in the field of criminal proceedings; analysis of legal norms and legal relations included in the field of professional activity; work on a computer, search, collection and analysis of legal and other information necessary for professional activity, including in search engines and the Internet; development and compilation of procedural documents of a legal nature; logical analysis of problematic situations;

Be competent in: practical activities for solving professional tasks, proficiency in professional vocabulary, using positive experience in law enforcement; using knowledge from various branches of law to draw up a plan for solving problems related to criminal offenses in the field of terrorism, extremism, drug trafficking, etc.; using professionally-oriented information technologies in the legal field, as well as databases and legal information processing processes; independent work with information, preparation of conclusions and recommendations on criminal law, criminal procedure, criminological issues; application of legal norms and theories in specific practical situations.

In order to create special conditions for people with special educational needs to receive education, the graduate's competence model is supplemented with professional competencies that ensure the adaptive nature of the main educational program. For this purpose, courses for the formation of the ability of persons with special educational needs to successfully socialize in society and actively adapt to the labor market, taking into account the characteristics of the disease, are introduced into the catalog of courses of the additional educational program «Minor».
