## Summary of the sections of the MEP

## 1. Explanatory note

The modular educational program (MEP) is compiled in accordance with the State Standard of Higher and Postgraduate Education, approved by Order  $\mathbb{N}_2$  of the Minister of Science and Higher Education of the Republic of Kazakhstan dated July 20, 2022; Rules for organizing the educational process on credit technology of education, approved by Order  $\mathbb{N}_2$  152 of the Minister of Education and Science of the Republic of Kazakhstan dated April 20, 2011; Model Rules activities of organizations of higher and (or) postgraduate education, approved by the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 30, 2018  $\mathbb{N}_2$  595.

The modular educational program (MEP) is designed as a set and sequence of training modules for the entire period of study and is aimed at mastering the competencies necessary for awarding the degree «Bachelor of Laws»according to the educational program 6B04222 «Investigative and prosecutorial activities». The OOD block includes disciplines for all educational programs (56 credits in total), during the study of which the graduate must master the competence of general education.

The DB block includes disciplines of the university component (VC), which is 41 credits and elective components (CV), which is 71 credits. Modules of these disciplines allow you to form a complex of system-forming competencies acquired by a graduate.

The PD block includes the disciplines of the university component (VC), which is 23 credits and the elective component (CV), which is 37 credits. Modules of these disciplines allow you to form a complex of special competencies acquired by a graduate.

Theoretical training - 228 credits, IA - 12 credits. In total, a student at the end of the MOS must master 240 credits. In total, the MOS contains 20 modules.

# The purpose of the educational program: Training of a specialist with professional competencies in the field of investigative and prosecutorial activities

# **Expected results of the educational program:**

- ON 1 Demonstrate general theoretical knowledge and understanding in the field of law based on the most advanced knowledge
- ON 2 apply knowledge and understanding at a professional level to formulate arguments and solve problems of investigative and prosecutorial activity
- ON 3 apply knowledge and understanding at a professional level to formulate arguments and solve problems in related areas of investigative and prosecutorial activity
  - ON 4 demonstrate knowledge and apply professional skills in investigative and prosecutorial activities in the field of business protection
- ON 5 to collect and interpret information for the formation of judgments in the field of investigative and prosecutorial activities, taking into account social, ethical and scientific considerations;
  - ON 6 apply theoretical and practical knowledge to solve educational, practical and professional tasks in investigative and prosecutorial activities
- ON 7 Analyze and systematize knowledge for acquiring practical skills in the field of pre-trial investigation of criminal cases necessary for independent continuation of further training
- ON 8 Analyze and systematize knowledge for the acquisition of practical skills in the field of prosecutorial supervision necessary for independent continuation of further education

- ON 9 To know the methods of scientific research and academic writing and apply them when drafting procedural documents

To create special conditions for people with special educational needs to receive education, there is a special graduate model supplemented with professional competencies that ensure the adaptive nature of the main educational program. For this purpose, courses for the formation of the ability of persons with special educational needs to successfully socialize in society and actively adapt to the labor market, taking into account the characteristics of the disease, are introduced into the catalog of courses of the additional educational program «Minor»

## 2. The graduate's competence model

Modern professional legal education is aimed at training highly educated competitive creative specialists capable of solving tasks aimed at building a fair civil society in the Republic of Kazakhstan and forming a mobile highly educated competent graduate.

The professional aptitude of a graduate is determined by a highly intellectual, general cultural level of development ready for activity and professional growth, possessing social and professional mobility, free to adapt in changing socio-economic conditions.

The competence of the graduate is formed taking into account the needs and satisfaction of the labor market.

The graduate is awarded the academic degree «Bachelor of Law» according to the educational program 6B04222 «Investigative and prosecutorial activity»

In order to realize their competitiveness and competence, a student under the educational program 6B04222 «Investigative and prosecutorial activity» receives at the educational institution «Alikhan Bokeikhan University»:

- a) the necessary amount of theoretical and legal knowledge for the formation of a personality and his professional suitability;
- b) applied skills in the application of theoretical knowledge in law enforcement;
- c) taking into account the needs of potential employers, students are given the opportunity to apply the knowledge, skills and abilities acquired during educational, industrial and pre-graduate practices, laboratory work, independent research, in practical activities.

All these separate elements of educational outcomes together constitute «competence».

Competence is the ability of a graduate to skillfully apply acquired knowledge, skills, and personal qualities in professional activities.

Students of the educational program 6B04222 «Investigative and prosecutorial activities» carry out their professional, analytical, consulting activities in the field of law enforcement and the judicial system.

Students enrolled in the educational program 6B04222 «Investigative and prosecutorial activities» study socio-humanitarian and legal disciplines that contribute to the intellectual development of the graduate, as well as contribute to the formation of professional knowledge, skills and abilities that allow them to skillfully apply the acquired knowledge in law enforcement. A graduate of this educational program must have professional knowledge and skills that allow them to independently apply solutions to problematic issues of investigative and judicial practice and prosecutorial supervision, analyze regulatory legal acts, carry out actions aimed at ensuring the rights and interests of the individual, society and the state.

# Classification of competencies according to the educational program 6B04222 «Investigative and prosecutorial activity»: Competence of general education:

- aimed at forming the ideological, civil and moral positions of the future specialist, competitive on the basis of knowledge of information and communication technologies, building communication programs in Kazakh, Russian and foreign languages, orientation to a healthy lifestyle, self-improvement and professional success;
- they form a system of general competencies that ensure the socio-cultural development of the personality of the future specialist on the basis of the formation of his ideological, civil and moral positions;
- develop the ability to interpersonal social and professional communication in Kazakh, Russian and foreign languages;
- contribute to the development of information literacy through the mastery and use of modern information and communication technologies in all areas of their lives and activities;
- form the skills of self-development and education throughout life;
- they form a personality capable of mobility in the modern world, critical thinking and physical self-improvement;

- to evaluate the surrounding reality on the basis of worldview positions formed by knowledge of the fundamentals of philosophy, which provide scientific understanding and study of the natural and social world by methods of scientific and philosophical cognition, to reveal the meaning of the content and specific features of the mythological, religious and scientific worldview;
- to show a civic position based on a deep understanding and scientific analysis of the main stages, patterns, peculiarities of the historical development of Kazakhstan, to use methods and techniques of historical description to analyze the causes and consequences of events in the history of Kazakhstan;
- to assess situations in various spheres of interpersonal, social and professional communication, taking into account basic knowledge of sociology, political science, cultural studies, psychology, arguing their own assessment of everything happening in the social and industrial spheres, as well as synthesize knowledge of these sciences as a modern product of integrative processes;
- to use scientific methods, methods of research of a specific science, as well as the entire socio-political cluster, to choose a methodology, analyze and summarize the results of the study;
- to develop their own moral and civic position on the basis of social, business, cultural, legal and ethical norms of the Kazakh society;
- to put into practice knowledge in the field of social sciences and humanities, which has worldwide recognition, synthesize new knowledge and present it in the form of humanitarian socially significant products;
- to engage in communication in oral and written forms in Kazakh, Russian and foreign languages, using language and speech means based on grammatical knowledge to solve problems of interpersonal, intercultural and industrial (professional) communication, as well as to analyze information, actions and deeds of communication participants in accordance with the communication situation;
- to use various types of information and communication technologies in personal activities: Internet resources, cloud and mobile services for the search, storage, processing, protection and dissemination of information;
- to build a personal educational trajectory throughout life for self-development and career growth, to focus on a healthy lifestyle to ensure full-fledged social and professional activities through methods and means of physical culture;
- to know and understand the basic laws of the history of Kazakhstan, the basics of philosophical, socio-political, economic and legal knowledge, communication in oral and written forms in Kazakh, Russian and foreign languages;
- apply the acquired knowledge for effective socialization and adaptation in changing socio-cultural conditions, possess the skills of quantitative and qualitative analysis of social phenomena, processes and problems.

**System–forming competencies** are an integral part of professional competence, contributing to the formation of personal qualities of students that determine the social significance of future professional activity, the skillful use of theoretical and applied knowledge and skills in law enforcement

### To know:

- correctly understand the legal foundations of the conceptual and categorical apparatus, general and particular methods and contents that form an idea of investigative and prosecutorial activity;
- theoretical foundations and practical features of document management, requirements put forward by the legislator to procedural documents of general and separate categories of criminal, administrative, civil cases;
- system-forming legal sources that organize and regulate the activities of the investigative apparatus of law enforcement agencies, as well as the activities of the Prosecutor's Office of the Republic of Kazakhstan;
- the legal basis and procedural procedure for the implementation of prosecutorial supervision in criminal proceedings, in addition, the activities of the prosecutor in the field of supervision of operational-investigative, criminal-executive activities;
- correctly understand and have a clear understanding of the fundamental and applied foundations of the national legislation of the Republic of Kazakhstan in the field of criminal, criminal procedure, administrative, civil and civil procedure proceedings;

## Be able to:

- on the basis of professional legal awareness and legal culture, correctly understand and apply the norms of the law of professional, law-making and law enforcement activities;
  - correctly apply national legislation, international norms, departmental normative legal acts of investigative and prosecutorial and judicial practice;
- on the basis of logical thinking and critical analysis, to make a conclusion on compliance with the rule of law, ensuring the rights and freedoms of the individual by criminal prosecution authorities in the course of professional activity;
- correctly use the acquired theoretical knowledge in the professional field, make decisions independently, draw up procedural documents related to the conduct of the preliminary investigation and prosecutor's office;
- professional activity to correctly interpret and apply the norms of criminal and criminal procedure legislation of the Republic of Kazakhstan, to conduct a comparative analysis with the norms of national legislation with the norms of foreign countries, to give a legally justified qualification of the composition of a criminal offense for illegal acts, on the basis of statistical data to conduct a criminological analysis of the state of crime in a certain administrative-territorial unit;
- correctly assess and know the purpose of the functions of prosecutorial supervision aimed at observing the rights and freedoms of persons involved in the sphere of criminal procedural legal relations, the legality of the production of operational investigative measures;
- correctly assess and know the purpose of the functions of prosecutorial supervision over the legality of the execution of criminal punishment by convicts in penal institutions, as well as the procedure for the execution of non-custodial sentences;
- on the basis of acquired knowledge, make decisions to identify and eliminate any violations of the rule of law, represent the interests of the state in court and supervise the legality of judicial decisions.

### Own:

- techniques and skills, the ability to carry out professional activities based on high legal awareness, legal culture and legal thinking;
- on the basis of theoretical knowledge and acquired practical skills, formed professional logical thinking, possess skills that allow you to adequately perceive the reality of law enforcement practice and successfully carry out work in the bodies of preliminary investigation and prosecutor's office;
- skills in the correct perception, application and interpretation of the norms of law in a professional environment related to the pre-trial investigation of criminal offenses and the function of prosecutorial supervision;
  - the ability to develop and execute procedural documents relating to the conduct of investigative and prosecutorial activities;
- the ability to accept and perform legal actions of employees of the prosecutor's office in accordance with the exact observance of laws and other regulatory legal acts;
- techniques and skills for the application of the norms of substantive and procedural law in the professional activities of the investigative apparatus of law enforcement agencies;
- techniques and skills for the performance of official duties of employees of the prosecutor's office, the investigator aimed at ensuring law and order, the security of the state, society and the individual.

**Special competencies** are an integral part of professional competence aimed at studying special legal disciplines, allowing students to apply and use the acquired knowledge in their professional activities.

#### To know:

- the essence and main directions of legal disciplines that contribute to the theoretical development and practical consolidation of the activities of the prosecutor's office and the investigative apparatus of law enforcement agencies;
  - departmental regulatory legal acts regulating the activities of criminal prosecution and prosecutorial supervision bodies;

- correctly understand the legality and validity of the actions and decisions of the pre-trial investigation bodies in the framework of the investigation of a criminal case;
  - effective methods and means of prosecutorial supervision within the competence of professional activity;
  - criminal-legal and criminal-procedural bases of criminal prosecution at the stage of pre-trial investigation by the investigator, prosecutor;
- the grounds, conditions and use of forensic methods and techniques during the investigation of a criminal case, including the conditions and features of the production of covert investigative actions;
  - theoretical and legal bases of the prosecutor's supervision over the legality of the pre-trial investigation;
- legality and order of serving sentences by convicts in penal institutions, supervision of the execution of sentences of convicts not related to deprivation of liberty, supervision of the legality of operational investigative activities;
- features of the prosecutor's activity in the process of international cooperation in criminal cases related to the provision of legal assistance to international law enforcement organizations and foreign criminal prosecution bodies;
  - legal grounds and conditions for the implementation of prosecutorial supervision of legality in administrative proceedings, civil proceedings;
- criminal procedural grounds for conducting a forensic examination during a pre-trial investigation, as well as applying the obtained scientific and special knowledge as evidence in criminal cases;
  - features and procedure for organizing the interaction of the investigator with the bodies of inquiry, the bodies of operational investigative activities;
  - applied fundamentals of forensic tools and methods that contribute to the disclosure and investigation of criminal offenses;
  - criminal procedural features and conditions of special powers of the prosecutor related to the production of a procedural agreement.

### Be able to:

- on the basis of a common legal culture and legal awareness, analytical thinking, from the position of civil responsibility and morality, to make legally justified decisions that comply with the letter of the law, the norms of morality and professional ethics;
- on the basis of theoretical knowledge and practical skills to apply forensic technical means, methods and techniques for the detection, consolidation and investigation of material and other evidence in criminal cases;
- on the basis of empirical data, to analyze the state of crime, to identify the causes and conditions that contributed to the commission of criminal offenses, to conduct a legal analysis of the state of crime in an administrative-territorial unit (district, region, republic), to set specific tasks to counteract a criminal offense on law enforcement agencies;
  - analyze and evaluate problematic issues of legal practice in the field of cooperation in the field of international criminal justice;
- it is procedurally correct to substantiate and involve persons with special scientific knowledge to assist in the discovery, research and use as evidence of factual data of importance in order to establish objective truth in a criminal case;
  - to correctly build their thoughts and justify the procedural decisions taken in a criminal case at the stage of pre-trial investigation;
- from the standpoint of the professional activity of the pre-trial investigation bodies, to carry out organizational and managerial functions related to the procedural features of the use of forensic special scientific knowledge, investigative and prosecutorial practice.

- practical skills that allow, on the basis of compliance with the law, independently conduct investigative actions, operational investigative measures, carry out prosecutorial supervision over the legality of pre-trial investigation, the legality of the court verdict;
- special legal skills that allow you to skillfully use the acquired knowledge and skills in criminal, civil and administrative legislation in professional activities:

- communication skills that contribute to the formation of a highly educated specialist who is able to analyze, detail investigative and judicial practice, build forecasts about the state and prevention of crime, make a decision on the facts of a procedural agreement on behalf of the prosecutor;
- organizational and managerial skills that allow you to independently carry out procedural actions aimed at uncovering and investigating a criminal offense, identifying the person who committed the illegal act and bringing him to criminal responsibility;
- practical skills of law enforcement practice of criminal proceedings in the field of international cooperation in providing legal assistance to international law enforcement organizations, foreign criminal prosecution authorities in matters of extradition, extradition of a person for criminal prosecution or serving a sentence in the State of which he is a citizen.
