Explanatory note

The modular educational program (MOE) is compiled in accordance with:

- The State Standard of Higher and Postgraduate Education, approved by Order No. 2 of the Minister of Science and Higher Education of the Republic of Kazakhstan dated July 20, 2022;

- Rules of the organization of the educational process on credit technology of training, approved by the Order of the Minister of Education and Science of the Republic of Kazakhstan dated April 20, 2011 No. 152;

- Standard rules of activity of organizations of higher and (or) postgraduate education, approved by the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 30, 2018 No. 595;

- The Law of the Republic of Kazakhstan dated July 27, 2007 No. 319-III "On Education" (with amendments and additions as of 01.09.2022)

- The Development plan of the educational program 6B04220 "Jurisprudence" 2021-2025 dated 28.01.2022 Protocol No. 6.

The modular educational program (MEP) is designed as a set and sequence of educational modules for the entire period of study and is aimed at mastering the competencies necessary for awarding the degree "Bachelor of Law" according to the educational program 6B04220 – Jurisprudence.

The GED block includes disciplines (56 credits in total), during the study of which the graduate must master the competence of general education.

The BD block includes disciplines of the university component (UC), which is 40 credits, and elective components (EC), which is 72 credits. Modules of these disciplines allow you to form a complex of general professional competencies acquired by a graduate.

The PD block includes the disciplines of the university component (UC), which is 23 credits and the elective component (EC), which is 37 credits. Modules of these disciplines allow you to form a complex of special competencies acquired by a graduate.

Theoretical training - 228 credits, FD - 12 credits.

In total, the student must master 240 credits (100%) at the end of the MEP. In total, the MEP contains 19 modules.

The purpose of the training is the formation of professional skills that ensure the protection, guarantee of compliance with the legitimate rights and interests of the state, individuals, legal entities arising in the legal sphere; the ability to navigate the

system, structure of state, including legal bodies; interpret the norms of various branches of law; analyze, solve legal problems in the field of civil law, labor, administrative-legal, criminal-legal and other relations.

Expected results of the EP:

ON 1 - Understand the importance of the principles and culture of academic integrity, systematize, summarize economic and legal information for use in professional activities, as well as navigate issues of market economy and entrepreneurship, analyze the phenomena of legal, economic order and know the organizational and legal forms

In order to create special conditions for people with special educational needs to receive education, the graduate's competence model is supplemented with professional competencies that ensure the adaptive nature of the main educational program. For this purpose, courses for the formation of the ability of persons with special educational needs to successfully socialize in society and actively adapt to the labor market, taking into account the characteristics of the disease, are introduced into the catalog of courses of the additional educational program "Minor".

The graduate's competence model

Classification of competencies of the educational program 6B04220 "Jurisprudence".
