Explanatory note

The Modular Educational program (MOPP) is compiled in accordance with:

- The State Standard of Higher and Postgraduate Education, approved by Order No. 2 of the Minister of Science and Higher Education of the Republic of Kazakhstan dated July 20, 2022;
- Rules of the organization of the educational process on credit technology of education, approved by the Order of the Minister of Education and Science of the Republic of Kazakhstan dated April 20, 2011 No. 152;
- Standard rules of activity of organizations of higher and (or) postgraduate education, approved by the Order of the Minister of Education and Science of the Republic of Kazakhstan dated October 30, 2018 No. 595;
- The Law of the Republic of Kazakhstan dated July 27, 2007 No. 319-III "On Education" (with amendments and additions as of 01.09.2022).

The modular educational program (MOPP) is designed as a set and sequence of educational modules for the entire period of study and is aimed at mastering the competencies necessary for awarding the degree "Bachelor of Law" according to the educational program 6B04201 - "Civil Service and judicial system".

The OOD block includes disciplines for all MOS of the educational program (a total of 56 credits), during the study of which the graduate must master general education competencies.

The DB block includes disciplines of the university component (VC), which is 38 credits, and elective components (CV), which is 74 credits. Modules of these disciplines allow you to form a complex of general professional competencies acquired by a graduate.

The PD block includes the disciplines of the university component (VC), which is 23 credits; and the elective component (CV), which is 37 credits. Modules of these disciplines allow you to form a complex of professional competencies acquired by a graduate.

Theoretical training-228kr, IGA – 12 credits.

In total, the student must master 240 credits (100%) at the end of the MOS. In total, the MOS contains 19 modules.

The purpose of the preparation is:training of highly qualified lawyers in the field of public service and the judicial system, competent, responsible, fluent in their profession and oriented in related fields of activity, capable of effective work in the specialty at the level of world standards, ready for continuous professional growth, social and professional mobility.

Expected results of the OP:

- **ON 1** Understand the legal terminology characterizing the state, law. Understand the system of law and the sectoral division of the legislation of the Republic of Kazakhstan. To form a civil position towards zero tolerance for corruption in order to familiarize the student with the principles of academic integrity.
- ON 2 Understand the content of the regulatory act and the procedure for its application in a specific legal situation, as well as ensure compliance with legislation
- **ON 3** Demonstrate an understanding of the essence of the branch of law, navigate the system and legal aspects of the activities of state bodies
 - **ON 4** To give qualified legal opinions in specific types of legal activity, to interpret the norms of civil legislation.
- **ON 5** Legally correctly qualify and apply regulatory legal acts, facts and circumstances, apply theoretical and practical knowledge to solve professional problems in the field under study.
- **ON 6** Possess the skills of preparing legal documents, correctly and fully reflect the results of professional activity in legal and other documentation.
- **ON 7** To understand the material and procedural procedures in the industry areas. Performs law enforcement, human rights and organizational and managerial functions.
- **ON 8** Analyze and solve legal problems of a theoretical and practical nature in the field of state regulation, fiscal, financial and economic, environmental, land and other legal relations.
